Subject: Cost study of Sugar Industry for fixation of levy sugar price.

Sir,

Attention is invited to letter No.3/12/2010-TC/Sectt dated 4th October, 2010 issued by the Secretary, Tariff Commission to all sugar mills with copy endorsed to you forwarding therein the questionnaire required for the study of the basic cost schedule for fixation of levy sugar price for the sugar season 2010-11 to 2012-13 which is to be submitted by all sugar mills. The reply to the above questionnaire was required to be submitted by 15th November, 2010. However, it has been intimated by the Tariff Commission that the response of the sugar mill for furnishing the reply to the Questionnaire is lukewarm.

2. The above questionnaire is one of the basic requirements of the sugar study being done by the Tariff Commission. As intimated by the Tariff Commission, the response of your member sugar factories has been very poor towards replies to the questionnaire. The fixation of levy price would get delayed in absence of input details for working out the same.

3. In order to get reply from sugar factories expeditiously, an order dated 13th April, 2011 has been issued with copy endorsed to you directing every sugar mill to submit reply to the questionnaire with in 30 days of the issue of said Order. A copy of the Order is again enclosed for your ready reference.
